Steps in your application for a Doctorate

- 1: Look yourself for a supervisor; contact the administration of the **institute/department** of the desired discipline of your doctorate. There is no list of supervisors at the University of Bern. Ask the department's/institute's administration if you need assistance.
- 2: Apply online at www.application.unibe.ch
- 3: Complete the confirmation of supervision
- 4: Confirmation of supervision incl. the following documents has to be passed on for signature to the supervisor:
 - a) Photocopy of your university degree (Master's degree or Licentiate)
or originally **certified photocopy** of your university degree and the translation, if your degree is issued in a language other than German, French, English or Italian
This does not apply to you if you achieved your degree at the same faculty where you want to pursue a doctorate.
 - b) Photocopy of your academic records (transcripts) or originally **certified photocopies** and the translation, if the list of academic records is issued in a language other than German, French, English or Italian
 - c) Originally certified photocopy of translation if your degree is issued in a language other than German, French, English or Italian.

 - d) Curriculum vitae in table form with uninterrupted chronology of your education and academic studies up to the present
 - e) Photocopy of your valid identity card (front and back) or valid passport
This does not apply to you if you are a former student of the University of Bern
 - f) Declaration of consent
- 5: Application file has to be passed for verification of your entrance qualification to the Admissions Office, Hochschulstrasse 4, 3012 Bern. If necessary, additional documents will be requested.
- 6: If you meet our admission requirements, the application file is passed on for signature to the dean's office of the relevant faculty or study coordination of the relevant graduate school
- 7: Fully completed confirmation of supervision and application file have to be passed on to the Admissions Office
- 8: Delivery of the invoice for the registration and semester fees for doctoral students
- 9: Issuance and delivery of information about your **Campus Account**, if you are new at the University of Bern
- 10: Submit the original of your degree for scrutiny to the Admissions Office
- 11: **Certificate of registration** and delivery of **UNICARD** following receipt of payment
